

# Euharlee Farmers Market Rules & Regulations – 2026 Season

*(A copy of these rules and regulations will be provided when the application and payment are received.)*

## 1. Market Schedule & Location

- The **Euharlee Farmers Market** will be held every **Wednesday**, with the anticipated time being **3:00 PM – 7:00 PM, June 3, 2026 – August 26, 2026**.
- The market will be located in the **Historic District**, near the **Granary and the Euharlee Library**.
- This move provides **more space for vendor growth, additional parking, and proximity to the campground**, which has remained **fully booked** since opening.

## 2. Vendor Selection & Application Process

- Vendors are **NOT** chosen on a first-come, first-serve basis.
- **Returning vendors must reapply**. Agricultural vendors will be given priority.
- The **application deadline is May 15, 2026**. Vendors will be notified of acceptance by **May 20, 2026**.
- No vendor may sell products at the market until their **application has been accepted** and the **market fee has been paid**.

## 3. Vendor Fees & Payment

- If selected, booth fees for the market season are due by **June 01, 2026**.
- **Accepted payment methods:** Card, Cash, or check.
- **Booth Fees:**
  - **Produce & Meat Vendors:** \$40 for the full season / \$25 for half season
  - **All Other Vendors:** \$50 for the full season (13 weeks) / \$30 for half season (6 weeks)
  - **Farmers/Produce Vendors Only:** A **one-week pass** will be available on a first-come, first-serve basis for **\$5 per week**. Requests must be made with the market coordinator **by the Saturday before the market day**.

## 4. Attendance & Cancellation Policy

- If a vendor cannot attend a scheduled market, written notice must be given **at least 3 days in advance**.
- If a vendor **misses 3 market days without notice or prior approval**, they will be **suspended** from the market.
- **All vendor fees are nonrefundable**.

## 5. Licensing & Compliance

- Vendors are responsible for meeting **local, state, and federal** requirements to sell their products.
- Examples include **food safety requirements and licensing**.
- Vendors may contact the **Georgia Dept. of Agriculture's Consumer Protection Division** at **404-656-3627** for more information.
- **Copies of required licenses, certifications, and other supporting documents must be submitted with payment.**

## 6. Market Guidelines & Vendor Responsibilities

- **All products must be vendor-produced. No reselling** is permitted. Any **intentional misrepresentation** of a product's origin is grounds for **immediate expulsion** from the market.
- Vendors may **not begin selling** until the official market start time.
- Vendors **must arrive no later than 30 minutes before** the market begins.
- Vendors must **park and set up only in designated spaces** assigned by the market manager.
- Spaces will be assigned **based on product balance and special requirements**. While we will attempt to keep vendors in the same location each week, changes may be necessary.
- Vendors **must leave their space clean** and free of trash or debris.
- Vendors **must bring their own setup**, including **tent, tables, and display materials**.
- **Tents are required for all vendors** and must be **properly secured with weights on each leg**.
- All tables must be covered with a **clean and presentable tablecloth**.
- Vendors must have **professional signage** clearly displaying their **business name**.
- **Pricing for all items must be clearly visible** to customers.

## 7. Market Conduct & Compliance

- The **City of Euharlee** reserves the right to **cancel the reservation of any vendor** who does not follow these rules.
- Vendors found to be in **violation of market policies** may be removed **without reimbursement**.

## 8. Respect & Kindness Policy

- **Respect and kindness are required** at the Euharlee Farmers Market.
- We expect all vendors to treat one another with the **same respect and kindness** they would like to receive.
- We are all here for the same purpose—**to support local agriculture, small businesses, and our community**—and should be working to **build each other up**.
- **Bullying, badmouthing, or discrimination of any kind will not be tolerated.**
- **Anyone engaging in such behavior will be immediately asked to leave the market.**

By participating in the market, vendors agree to uphold these values and contribute to a **positive, welcoming environment** for all.

We appreciate your cooperation in making the **Euharlee Farmers Market** a **successful and welcoming** experience for both vendors and customers. **Thank you for being part of our market community!**
